Two copies of the duly filled and serialized hard copy bids shall be deposited at the tender box located at the **CLUB RECEPTION** while soft copy bids shall be emailed to secretary@nanyukisportsclub.co.ke and copied to engngaru@gmail.com so as to be received on or before **Tuesday, 16th December 2025, 1400 Hrs.**

Tender documents shall be opened from **1400hrs on the same day and same venue**, in the presence of bidders or their representatives who choose to attend the opening session. Tender opening shall be hybrid. Bidders who choose to attend virtually shall be provided with a video link and log in credentials before the tender opening. The bid security must remain valid for a period of **One Hundred and Twenty (120) days** from the date of tender opening.
